

## Accreditation Fees

Please note all fees are non-refundable and subject to change.  
Admin fees will apply to reinstate your accredited courses.

### Qualification Accreditation

An FHT Accredited qualification is a training course that follows the National Occupational Standards (NOS) and Core Curriculum - where available - for the therapy and one that qualifies the student to Practitioner Level.

Where there are no standards for the therapy, FHT Accreditation confirms that the course meets the minimum standards set or approved by the FHT for proficiency and best practice. Therapists qualifying in an FHT Accredited qualification can gain FHT Membership and insurance to practise.

An FHT Accredited qualification will qualify for FHT Continuing Professional Development (CPD).

### Short Course Accreditation

An FHT Accredited short course is a training course that on its own does not follow the National Occupational Standards (NOS) and Core Curriculum for a therapy and one which may not qualify the student to Practitioner Level.

FHT Accredited Short Courses can fall into one of four categories:

- Further learning – a course that expands on a therapy that follows the NOS or FHT standards as best practice - e.g. Hot Stone Reflexology.

***The training provider must check that students - have the relevant pre-requisites before acceptance onto the course***

- Taster Workshops – designed as an introduction to a therapy
- Individual Units – for those who may offer individual modules/units which lead to a qualification but which do not represent practitioner level in isolation.
- Online courses that are theory based can also be classified as short courses, e.g. Nutritional Advice.

An FHT Accredited Short Course will qualify for FHT Continuing Professional Development (CPD).
