What is personal data?

Personal data is information relating to an identified or identifiable natural person, such as name, age, address, date of birth, gender and contact details.

Personal data may contain information that is known as 'sensitive' data. This may be information relating to an individual's health, racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, genetic and biometric data, or data relating to or sexual orientation. Data relating to criminal convictions and offences is also considered sensitive data.

What information do we collect about you?

We collect information about you when you apply to become a member with us or place an order for products or services. We also collect information when you voluntarily complete customer surveys, provide feedback and participate in competitions. Website usage information is collected using cookies.



We will process the categories of data below for the performance of our contract with you to provide membership and, if you agree, to email you about other products and services we think may be of interest to you. Where you require it, we will also use the information to quote for and provide insurance products and services, to process claims and renewals, to administer your policy and to respond to any requests from you about services we provide and to process complaints.

Payment information – payment card details are not stored on our systems, but if you pay by direct debit we will retain your direct debit mandate for at least the duration of your membership with the FHT

Special categories of personal data such as health and details on historic claims resulting in injury (physical and physiological)

Data relating to criminal convictions and offences such as insurance fraud – this information may not be stored, but depending on the severity of the offence and if the conviction is unspent, may determine whether or not we are able to provide you with our products and services

If you object to the collection, sharing and use of your personal data we may be unable to provide you with our products and services.

How will we use the information about you?

We collect information about you for the performance of our contract with you to provide membership and, where you require it, insurance.

The information you supply on our Formsite application forms will be securely transferred outside of the European Economic Area (EEA) in order to process your application. We also collect information about you, if you agree, to email you about other products and services we think may be of interest to you.



Where you require it, we will also use the information to quote for and provide insurance products and services, to process claims and renewals, to administer your policy and to respond to any requests from you about services we provide and to process complaints.

As part of your membership, you will receive a welcome pack, insurance documentation, The International Therapist magazine, industry news updates and renewal invite information by post. We will share your information with our insurance providers CBC Insurance (broker) and Hiscox UK (underwriter), if you are taking out insurance with us, and with our Media Partner, Century One, and mailing house, Seabourne Logistics who manage and send out your membership magazine, The International Therapist.

FHT will not share your information for marketing purposes with companies outside FHT.

We use your information collected from the website to improve your repeat visits to our website.

Data retention

We will retain your personal data at the end of any contractual agreement for a period of four years if you hold insurance through the FHT or for a period of two years if insurance cover is held elsewhere.

Where you have submitted a claim, we will retain this data for the duration of your membership with the FHT. If your membership has lapsed or is cancelled within three years of the initial claim notification, the FHT reserves the right to retain your data at least until that three year period has elapsed, in line with the current legislation for medical malpractice claims, and up to a maximum of 10 years to allow any ongoing claims to be settled.

Where you make a complaint we will retain the data for the duration of your membership.

Where you or law enforcement agencies inform us about any active investigation or potential criminal prosecution, we will comply with legal requirements when retaining this data.

Your rights

These rights are known as Individual Rights under the Data Protection Act 2018. The following list details these rights:

The **right to be informed** about the personal data being processed;

The **right of access** to your personal data;

The **right to object** to the processing of your personal data;

The **right to restrict** the processing of your personal data;

The **right to rectification** of your personal data;

The **right to erasure** of your personal data;

The **right to data portability** (to receive an electronic copy of your personal data);

Rights relating to automated decision making including profiling.

The retaining of data is necessary where required for contractual, legal or regulatory purposes.

In rare instances we may need to retain your data for longer, for example if we are representing you or defending ourselves in a legal dispute or as required by law or where evidence exists that a future claim may occur.
